3. Budget Revision

- 3.1 **RESOLVED:** that the Board of Education approves an increase in the 2016-2017 General Fund Revenue and Appropriation Budgets in the amount of \$1,123.75 for the purchase of a Smart Board, with funds donated from The Cherry Lane PTA, as per the attached.

4. Updated Recommendation for Energy Performance Contract #2

- 4.1 **RESOLVED:** that the Board of Education approves the performance contract between the Carle Place Union Free School District and Johnson Controls, Inc. for an energy performance contract consisting of district-wide energy saving cost measures in the amount of \$2,178,507, and;

BE IT FURTHER RESOLVED that the Board of Education President is hereby authorized to execute this contract and any other documents related to this project that may be required to be submitted to the State Education Department.

5. Use of District Repair Reserve Fund

- 5.1 **WHEREAS,** a public hearing having been held by the Board of Education on March 30, 2017 pursuant to New York General Municipal Law §6-d relating to an expenditure from the Repair Reserve Fund established by the Board with funding approved by district residents on May 21, 2013;

BE IT RESOLVED, that the Board of Education approves the expenditure from the district's Repair Reserve Fund in an amount not to exceed SIXTY THOUSAND (\$60,000) DOLLARS for the replacement of a water heat exchanger at the high school.

6. 2017 - 2018 Budget Propositions

- 6.1 **RESOLVED:** that the Board of Education approves the adoption of a budget in the amount of \$49,279,492 for the 2017 – 2018 school year.

BE IT FURTHER RESOLVED, that this budget shall be listed as Proposition One (1) on the ballot for voters on May 16, 2017.

BE IT FURTHER RESOLVED, that the Board of Education approves as Proposition two (2) on the ballot for voters on May 16, 2017:

Shall the Board of Education of the Carle Place Union Free School District be authorized to establish a Capital Reserve Fund to be known as the “District-wide Equipment, Renovations, Reconstruction, and Construction Reserve Fund 2017” in an amount not to exceed the total estimated cost of \$10,000,000, which shall be for the purpose of:

- acquiring capital equipment,
- paying the costs for the renovation, reconstruction and construction of District buildings, including planning costs, site work and renovation, reconstruction and construction costs

and shall be funded by the unexpended appropriations and/or excess revenue in any given school year, with a probable term of fifteen (15) years.

BE IT FURTHER RESOLVED, that the Board of Education approves as Proposition Three (3) on the ballot for voters on May 16, 2017:

Shall the Board of Education be authorized pursuant to Section 3651 of the Education Law to appropriate and expend a total amount not to exceed the total estimated cost of \$169,134, from the capital reserve fund established by the voters of the School District at the Annual meeting held on May 20, 2008, for the project listed below:

- Replacement of all remaining original interior doors at the Cherry Lane School and any other work required in connection therewith.

BE IT FURTHER RESOLVED, that the Board of Education approves as Proposition four (4) on the ballot for voters on May 16, 2017:

Shall the Board of Education be authorized pursuant to Section 3651 of the Education Law to appropriate and expend a total amount not to exceed the total estimated cost of \$4,694,910, from the capital reserve fund established by the voters of the School District at the Annual meeting held on May 21, 2013, for the projects listed below:

- complete abatement of five (5) classrooms and attached areas at the Rushmore Avenue School
- a partial abatement of the crawlspace at the Rushmore Avenue School
- the purchase and installation of a district-wide portable radio repeater system and related handheld portable radios
- districtwide asbestos abatements
- upgrades, controls and retrofits to energy management systems, steam trap replacements, heating distribution system and insulation, window film, plug load controllers, and any other work required in connection therewith.

BE IT FURTHER RESOLVED, that the Board of Education approves as Proposition five (5) on the ballot for voters on May 16, 2017 the election of two (2) members of the Board of Education for a three-year term commencing July 1, 2017 and expiring on June 30, 2020.

7. Donation

- 7.1 **RESOLVED:** that the Board of Education accepts, with gratitude, the donation of \$1,123.75 from the Cherry Lane School Parent/Teachers Association to be deposited to the General Fund.
