6. <u>Inter-Municipal Cooperative for Bidding for Transportation Services (BOCES) 2018-</u> 2019

6.1 **WHEREAS**, a number of public school districts in Nassau County wish to jointly solicit proposals, together with the Nassau Board of Cooperative Educational Services ("BOCES") for pupil transportation services for the 2018-19 school year (and any renewal period) in accordance with the applicable provisions of General Municipal Law;

WHEREAS, the public school districts and the BOCES have agreed to form a Cooperative (the "Cooperative") for this purpose;

WHEREAS, the Carle Place Union Free School District is desirous of participating in the Cooperative for joint solicitation of proposals for pupil transportation services as authorized by General Municipal Law, Section 119-0 in accordance with the terms and conditions of the Inter-Municipal Cooperative Transportation Agreement attached hereto;

NOW THEREFORE BE IT RESOLVED, that the Board of Education authorizes the School District to participate in the Cooperative; and

BE IT FURTHER RESOLVED, that the Board of Education hereby approves the Inter-Municipal Cooperative Transportation Agreement (Recitals) attached hereto and authorizes the Board President to execute the Agreement on behalf of the Board of Education.

7. 2018 - 2019 Budget Propositions

7.1 **RESOLVED:** that the Board of Education approves the adoption of a budget in the amount of \$49,440,424 for the 2018 – 2019 school year.

BE IT FURTHER RESOLVED, that this budget shall be listed as Proposition One (1) on the ballot for voters on May 15, 2018.

BE IT FURTHER RESOLVED, that the Board of Education approves as Proposition Two (2) on the ballot for voters on May 15, 2018:

Shall the Board of Education of the Carle Place Union Free School District be authorized and directed to establish a Repair Reserve Fund in an amount not to exceed One Million Dollars (\$1,000,000), to pay the cost of repairs to capital improvements or equipment, which repairs are not recurring annually, which shall be funded by the unexpended appropriations and/or excess revenue in any given school year, with a probable term of five (5) years.

BE IT FURTHER RESOLVED, that the Board of Education approves as Proposition Three (3) on the ballot for voters on May 15, 2018:

Shall the Board of Education be authorized be authorized pursuant to Section 3651 of the Education Law to appropriate and expend a total amount not to exceed the total estimated cost of \$1,730,090 from the capital reserve fund established by voters at the Annual meeting held on May 21, 2013, for district-wide security camera and security network replacements and upgrades; additional funds to complete the door replacement project at the High School; additional funds to complete the electrical system upgrades at the High School; and a portion of the Phase III abatement and reconstruction costs at the Rushmore Avenue School (north west section of the first floor, cafeteria walls and music rooms).

BE IT FURTHER RESOLVED, that the Board of Education approves as Proposition Four (4) on the ballot for voters on May 15, 2018:

Shall the Board of Education be authorized pursuant to Section 3651 of the Education Law to appropriate and expend a total amount not to exceed the total estimated cost of \$2,269,910 from the capital reserve fund established by voters at the Annual meeting held on May 16, 2017, for the remaining costs of the Phase III abatement and reconstruction costs at the Rushmore Avenue School (north west section of the first floor, cafeteria walls and music rooms).

BE IT FURTHER RESOLVED, that the Board of Education approves as Proposition Five (5) on the ballot for voters on May 15, 2018:

The election of two (2) members of the Board of Education for a three-year term commencing July 1, 2018 and expiring on June 30, 2021.

BE IT FURTHER RESOLVED, that the Board of Education approves as Proposition Six (6) on the ballot for voters on May 15, 2018:

The election of one (1) member of the Board of Education for an unexpired term that commenced on July 1, 2017 and expires on June 30, 2020, with the successful candidate for such unexpired term being eligible to take office immediately upon being elected and duly qualified.
