#### 4. Liquidation of Reserve for Tax Certioraris

**4.1 RESOLVED:** that in accordance with the requirements of Education Law §3651(1-a), the Board of Education hereby liquidates the entire balance in the Reserve for Tax Certioraris and returns all funds to the General Fund.

#### 5. <u>Authorization For Cooperative Request For Proposal For Ancillary and Related</u> <u>Special Education Services</u>

**5.1 WHEREAS,** a number of public school districts in Nassau County wish to jointly solicit proposals for Special Education Related Services, to commence in the 2014-2015 school year, in accordance with the applicable provisions of General Municipal Law;

WHEREAS, the Carle Place School District desires to participate with these school districts for the joint solicitation of proposals for Special Education Related Services as authorized by General Municipal Law Section 119-o, in accordance with the terms and conditions of the attached Inter-Municipal Cooperative Agreement ("IMA") among the participating school districts; and,

**WHEREAS,** the Board of Education has determined that it would be in its best financial interest to solicit proposals for Special Education Related Services on a cooperative basis; now, therefore,

**BE IT RESOLVED** that the Board of Education hereby authorizes the School District to participate with other Nassau County public school districts for the solicitation of proposals for Special Education Related Services on a cooperative basis, subject to the IMA's terms and conditions; and

**BE IT FURTHER RESOLVED,** that the Board of Education hereby accepts and approves the appointment of the Manhasset Union Free School District as the Lead Participant for purposes of facilitating and coordinating the solicitation of proposals in accordance with the IMA; and

**BE IT FURTHER RESOLVED** that the Board of Education hereby approves the attached IMA and authorizes the Board President to execute the IMA on behalf of the Board of Education.

#### 6. <u>2014 – 2015 Budget Propositions</u>

**6.1 RESOLVED:** that the Board of Education approves the adoption of a budget in the amount of \$48,180,796 for the 2014 – 2015 school year.

**BE IT FURTHER RESOLVED,** that this budget shall be listed as Proposition One (1) on the ballot for voters on May 20, 2014.

**BE IT FURTHER RESOLVED,** that the Board of Education approves as Proposition Two (2) on the ballot for voters on May 20, 2014:

Shall the Board of Education be authorized pursuant to Section 3651 of the Education Law to appropriate and expend a total amount not to exceed \$1,000,000, from the capital reserve fund established by voters of the School District at the Annual meeting held on May 20, 2008, for the projects listed below:

- Repairs to the roof, leaders and gutters at the Rushmore Avenue School;
- Repairs to the auditorium ceiling at the Rushmore Avenue School;
- Parking lot resurfacing and drainage improvements at the Rushmore Avenue School;
- Provide secure public restroom access at Rushmore Avenue School;
- Upgrades to the Middle School/High School heating system including related abatement of asbestos containing materials;
- Install "fall protection" for all skylights in the Middle School/High School;
- Renovate perimeter fencing and landscaping associated with new athletic facilities;
- Complete a variety of asbestos abatement projects in the Middle School/High School;
- The purchase of a new pickup truck/snow plow.

**BE IT FURTHER RESOLVED,** that the Board of Education approves as Proposition Three (3) on the ballot for voters on May 20, 2014 the election of two (2) members of the Board of Education for a three-year term commencing July 1, 2014 and expiring on June 30, 2017.

#### 7. <u>Board Resolution for Participation in Inter-Municipal Cooperative for Bidding</u> <u>Transportation Services for the 2014-15 School Year and for the Summer 2014</u>

7.1 WHEREAS, a number of public school districts in Nassau County wish to jointly solicit proposals, together with the Nassau Board of Cooperative Educational Services ("BOCES") for pupil transportation services for the 2014-2015 school year and Summer 2014 (and any renewal period) in accordance with the applicable provisions of General Municipal Law;

**WHEREAS,** the public school districts and the BOCES have agreed to form a Cooperative (the "Cooperative") for this purpose;

**WHEREAS,** the Carle Place School District, is desirous of participating in the Cooperative for joint solicitation of proposals for pupil transportation services as authorized by General Municipal Law, Section 119-0 in accordance with the terms and conditions of the Inter-Municipal Cooperative Transportation Agreement attached hereto; and,

**NOW THEREFORE BE IT RESOLVED** that the Board of Education authorizes the School District to participate in the Cooperative.

**BE IT FURTHER RESOLVED** that the Board of Education hereby approves the Inter-Municipal Cooperative Transportation Agreement attached hereto and authorizes the Board President to execute the Agreement on behalf of the Board of Education.

#### 8. <u>Health and Welfare Services Agreement</u>

8.1 **RESOLVED:** that the Board of Education approves the health and welfare services agreement with Hicksville Union Free School District and the Carle Place Union Free School District from July 1, 2013 through June 30, 2014 as per attached, and authorizes the Board of Education President to execute same.
