## **ADDENDUM TO THE AGENDA**

## 12. Adoption of School Calendar

- **12.1 RESOLVED:** that the Board of Education approves the updated calendar as per the attached, pending the approval of a formal, written agreement with the Carle Place Teachers' Association. These calendar changes result from the six (6) days of instruction lost due to the effects of "Superstorm Sandy" and the snowstorm of November 8, 2012. The changes include:
  - a. The cancellation of 1/2-days of instruction previously scheduled for the purpose of professional development. These ½-days (12/3/2012, 2/4/2013, 4/15/2013, and 5/13/2013) have been rescheduled to full days of instruction for all students. March 25, 2013 and April 1, 2013 are now full days of instruction, as noted in the calendar originally approved by the Board of Education for the 2012 2013 school year on July 2, 2012.
  - b. The rescheduling of mid-term week at Carle Place MS/HS to allow for full days of instruction from 1/22/2013 through 1/25/2013.
  - c. Full days of instruction are now scheduled on Wednesday, February 20, 2013 and Thursday, February 21, 2013. These days had previously been scheduled as part of the "Winter Recess."
  - d. The addition of up to two Superintendent's Conference Day on June 24 and 25\*, 2013 for the purpose of staff development activities related to implementation of high learning standards and assessments, as adopted by the Board of Regents.
  - e. The scheduling of four additional "Emergency Closing Make-Up Days." These days would cause school to re-open in the following order:
    - i. \*June 25, 2013 as a Superintendent's Conference Day for teachers only. If one additional emergency closure occurs during the 2012-2013 school year, teachers will report on this day. If no additional "emergency closing days" are needed for the current academic year, the teachers will not be required to report to school on this date.
    - ii. If a second additional emergency closure date is needed during this academic year, Tuesday, March 26, 2013 will be a full day of instruction.
    - iii. If a third additional emergency closure date is needed during this academic year, Wednesday, March 27, 2013 will be a full day of instruction.

iv. If a fourth additional emergency closure date is needed during this academic year, Thursday, March 28, 2013 will be a full day of instruction.

Nothing contained herein shall provide for additional paid days off to employees. Furthermore nothing contained herein shall amend any collective bargaining agreement, policy or practice, or set any precedent or practice.
